	<p>Victim of Neglect</p> <p>A juvenile is considered to be victim of neglect in the following cases:</p> <ul style="list-style-type: none">• Present in an environment that threatens his/her health, safety or morals.• Subjected to sexual assault.• Exposed to physical violence that exceeds the limits of what is culturally considered as a form of harmless discipline.• Found begging.

1.7 Victim of Trafficking



Victim of Trafficking

A juvenile is considered to be victim of trafficking in the following cases:

- Engaged in prostitution
- Sexual exploitation
- Begging
- Servitude
- Forced recruitment of children for use in armed conflicts
- Forced involvement in terrorist acts
- Removal of organs or tissues from the victim's body

1.8 Victim of Labor



Victim of Labor

A juvenile is considered to be victim of labor in the following cases:

- Forced to labor under the age of thirteen.
- Forced to perform work that poses a danger to their health, safety or morals under the age of eighteen.

1.9 Victim of Information and Communication Technology



Victim of Information and Communication Technology

A juvenile is a victim of information and communication technology in the following cases:

- Grooming to obtain information or take photographs.
- Forging false images and videotapes of the child.
- Distributing or threatening to distribute these materials.
- Sending information, e-mails, commercial advertisements or content that is offensive, violent, biased, racist or hateful.
- Uploading or downloading harmful games.
- Sending inappropriate sexual materials or misleading information.
- Cyber-bullying.

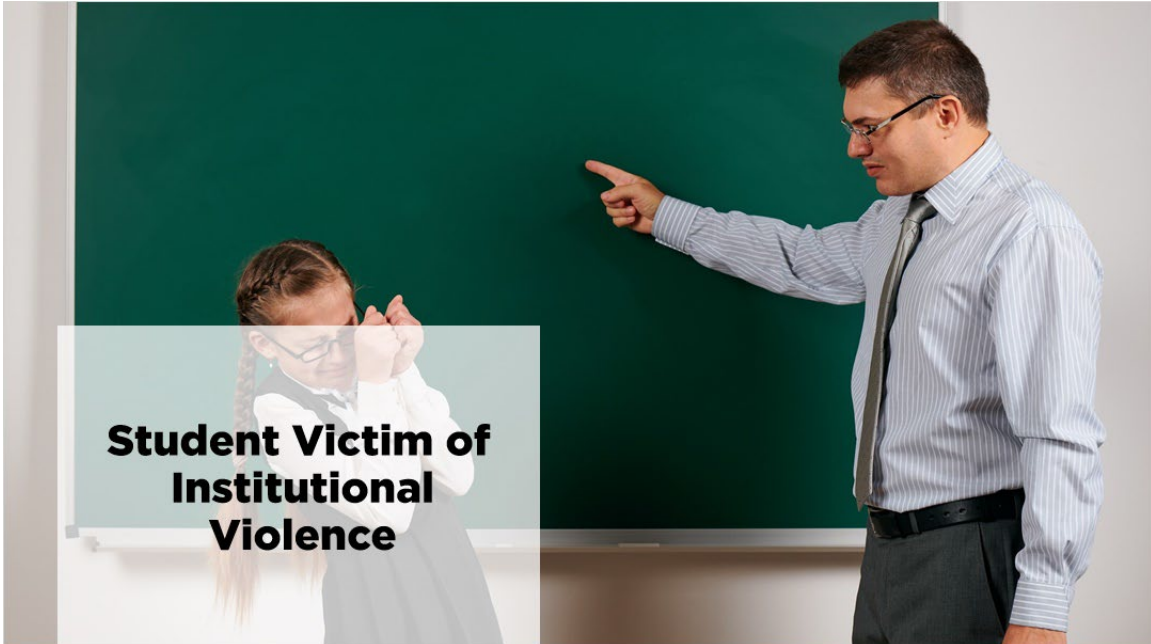


Student in Conflict with the Law

A student is considered to be in conflict with the law in the following case:

The juvenile student over the age of seven years or the adult student who commits an offense against the Lebanese law and if the offense occurs within the school campus or outside of the campus but within the sight of a school employee.

Student Victim of Institutional Violence

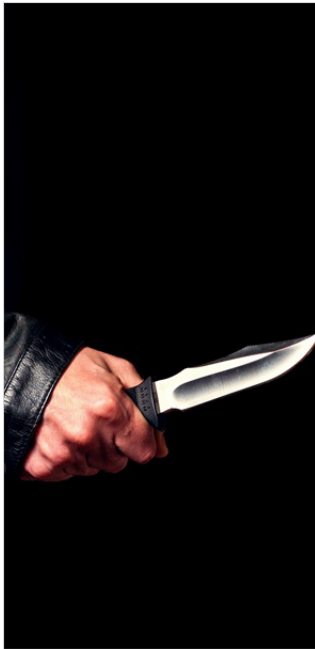
A student is a victim of school institutional violence if he/she is exposed to:

- Collective punishment.
- Individual punishment.
- Marginalization, ridicule and contempt.
- Corporal punishment.
- Maltreatment.
- Discrimination on the basis of race, color, religion, nationality, name and gender.
- Exploitation.
- Denial of rights such as eating, resting, going to the toilet.
- Threats in all their forms and blackmail.
- Verbal violence, including cursing and profanity.

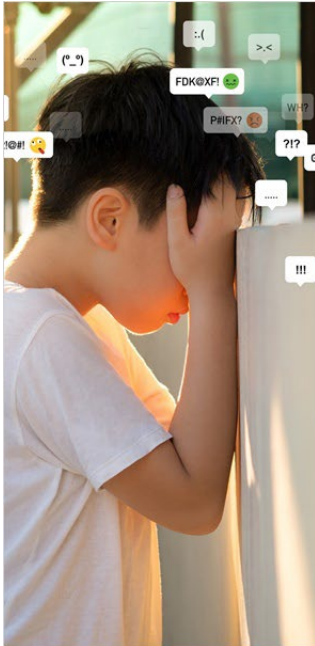


Student Assailant in the School Environment
